

Data Privacy Policy for Hawa AG's Website

This statement sets forth our privacy policy for the website of Hawa AG, describing the practices we follow to respect the protection of privacy of all visitors.

At Hawa AG, we have been focused on implementing fair information practices that are designed to protect your data privacy effectively. We believe that everyone benefits from the free flow of information when that information is gathered and used responsibly. If you are merely a visitor to www.hawa.ch, Hawa AG does not collect any personal or company information about you or your company, except for the limited extent described below. There are a number of circumstances, however, in which we may collect data, especially upon your specific request for any further information or for specific contact by one of Hawa AG's distributors.

Data Security/Integrity. Hawa AG has technological and operational security functions in place to protect personally identifiable information from any loss, misuse, alteration, or destruction. The data you may provide is shared only with authorized employees of Hawa AG, its affiliates, or subsidiaries, and on a limited basis, with distributors who will supply information or further data for your benefit. Access to your information is limited by need, and those who will have access to the data have agreed to maintain the confidentiality of such information. In addition, Hawa AG may disclose personally identifiable information only as may be required by subpoena, search warrant, or other legal processes.

Accountability. Hawa AG supports and is involved in consumer, government and industry efforts to identify and resolve privacy issues.

Changes to this Policy. Hawa AG may change this policy as needed. If changes to this statement are made, please note that it may take up to 30 business days before new privacy practices are implemented.

Purpose of Collection, Processing or Utilization of any Data submitted by you or your Company.

The main purpose of collection, processing or utilization of the data is to promptly respond to any inquiries as to our products, the sale, distribution and servicing of sliding hardware systems as well as the offering of services for sliding hardware systems. In addition, we intend to collect such data in order to provide you or your company, on an ongoing basis, with information related to any up coming trade shows, presentations, and seminars related to Hawa AG's products and services. The collection, processing and utilization of any such data provided by you and your company are strictly limited to fulfill such above named purposes. Furthermore, Hawa AG's website may use web analytics services provided by third party service providers who use "cookies", which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored on servers in Switzerland or in the United States. Our company as well as any third party service providers will use this information solely for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Our company may also transfer this information to third parties if and when required to do so by law, or when such third parties process the information. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website. By using Hawa AG's website, you consent to the processing of data about you by third party service providers in the manner and for the purposes set out above. Except as indicated above, we may only share your personal or company data with employees of Hawa AG, its affiliates, subsidiaries, or specific distributors of Hawa AG who are located in your specific geographic region. Your data will not be accessible to any other third persons, and your data will only be used in relation to, or in connection with, your specific orders or inquiries.

Deletion of the Data collected and stored. Legislation has stipulated a wide range of obligations for the collection and storage of data. After expiration of such periods, the corresponding data will be routinely deleted by Hawa AG. In addition, unrelated to these foresaid timeframes, we will delete such data as soon as the purpose outlined above does not exist any longer.
